Summary Minutes of the Council Meeting held on 21st March 2017 at 7pm in the Village Hall, Main Street, Burton Salmon.

- 93. 16/17 Members of the Public – subjects raised:** None present
- 94. 16/17 Declarations of Interest:** - Cllr Raine declared that she is no longer working at Selby District Council.
- 95. 16/17 Minutes of the Parish Council Meeting 31th January 2017:** - The minutes were approved as a true record.
- 96. 16/17 Matters arising:-**
96.16/17.1. Traffic issues – The traffic queues warning sign has now been installed.
 School staff/visitors arriving during the school day can now to park in a designated area of the school yard. The residents meeting which was well attended and pupil safety officers ticketed cars, but problems continue. Clerk to organise meeting to discuss the possibility of restricting parking times on Ledgate Lane. Damage to footpaths on Ledgate Lane to be reported to NYCC.

Resident complaint about dirt and dust from Darrington Quarry and poor state of footpath on A162. – to be reported
SDC invitation to planning process – no one to attend.
Resident request to support Cricket Club funding application – agreed to provide a letter of support.
Resident request to reconsider CCTV decision – unaffordable so previous decision stands.

- 98. 16/17 Village Hall:** - 98.16/17.1. Purchase of Hall – The purchase is still delayed due to legal issues.
98.16/17.2. Running of the Hall – Income has reduced and new projects and refurbishments await the sale completion.

103. **16/17 Street Light Maintenance:** - Ivy to be removed from the sensor on Light 11. Light on Lunnfield Lane reported to NYCC again.

104.16/17.2. Brotherton Quarry Community Liaison Committee: The next meeting is at the end of May which will include a site visit.
