

BURTON SALMON PARISH COUNCIL

Minutes of the Council Meeting held on 30 January 2018 at 7pm in the Village Hall, Main Street, Burton Salmon.

65. **17/18 Present:** - Cllr Wroe, Cllr Foster Cllr Holmes, Cllr Anderson, County Cllr Pearson, one Parishioner and Clerk Meir.

Apologises: - Cllr Raine and District Councillor Mackman

66. **17/18 Members of the Public – subjects raised:** - A parishioner asked that the dog waste bin on the corner of Burton Common Lane and Poole Lane be re-located further down Burton Common Lane. The Parish Council advised that if this was done a second bin would need to be purchased to be located down Poole Lane. The parishioner agreed to pay the costs involved. **Resolved:** The Parish Council agreed to look into possible alternative sites for the bins.

67. **17/18 Declarations of Interest:** - None

68. **17/18 Minutes of the Parish Council Meetings 21st November 2017:** - The minutes were approved as a true record.

69. **17/18 Matters arising:** - 69.17/18.1. Traffic and road issues: The parking restrictions on Ledgate Lane are due to be re-advertised. The double yellow line on Main Street have not yet been extended. **Action:** Clerk to chase and request an update on the examination of the A162 accident data.
- 69.17/18.2. Footpath issues: Some vegetation on Ledgate Lane still to be cleared. SDC have started work to repair the hazardous footpath from Main Street to Beech Grove. The footpath opposite the school has been damaged by car parking on it. **Action:** clerk to report.
- 69.17/18.3. War Memorial repairs: The full funding application needs to be submitted to the War Memorial Trust. Another quote is being obtained.
- 69.17/18.4. Gully drain problems: A request was made for the gully drains to be swept as they are full with leaves and farm waste, but NYCC advised that they did not meet the criteria for action.
- 69.17/18.5. Community Emergency Planning: Information collected to be pulled together into the document so any gaps can be identified. Vulnerable people will be identified as part of a questionnaire being prepared for the village hall.
- 69.17/18.6. Protection of the village pub: The Parish Council would not wish to purchase the pub but would like to protect it for the community. Agreed to look again at the requirements to register it as a community asset and seek advised from First Yorkshire.
- 69.17/18.7. Councillor vacancy: Cllr Vernon has resigned and no election has been requested so the Parish Council can co-opt to the vacancy. There are now two vacancies and some potential candidates have been identified but need to check eligibility.
- 69.17/18.8. Village planters: They will be filled with plants when the weather improves.
- 69.17/18.9. Fly-tipping signs: All but two of the signs have now been put up. The sign on Betteras Hill Road but has been removed. To ask Fairburn Parish Council to put a sign on Lunnfields Lane.
70. **17/18 Correspondence:** - 70. 17/18.1. NYCC – Information on their street light replacement programme noted.
70. 17/18.2. NYCC – Information that five low pressure sodium lamps will be obsolete from 2019-20 noted. **Resolved:** to replace the lamps upon failure.
70. 17/18.3. Resident - Complaint made about dog fouling on Ledgate Lane. The resident has been informed about extra signs that have been put up and advised to report any known offenders to SDC.
- 70.17/18.4. NYCC – Submission of Minerals and Waster Joint Plan to the Secretary of State for independent examination noted.
- 70.17/18.5. NYCC – Information on reporting speed concerns and how they are dealt with noted.
- 70.17/18.6. North Yorkshire Police – Warnings of telephone scams and the launch of freeze on Fraud campaign noted.

70.17/18.7. NYCC – Rural Selby Children’s centres programme of activities noted and publicised on the website.

70. 17/18.8. Accentia Arts Ltd – Company are framing pictures of the local area for The Plough and requested information on where they might find more images. None known to the Parish Council.

70.17/18.9. Tadcaster and Rural CIC Ltd– Invitation to a Community Rights Workshop on 23rd February. **Action:** Clerk to ask Cllr Raine if she would like to attend.

70.17/18.10. North Yorkshire Police – Survey to complete if want to comment on proposals for a community panel.

70.17/18.11. SLCC – Information about General Data Protection Regulation coming into force in May 2018. Full implications not yet known so further guidance awaited.

70.17/18.12. Selby District Vision – Charity Concert at Selby Abbey on 10th March noted and publicised on the website.

70.17/18.13. SDC Chairman – Charity 40’s Concert at St Wilfrid’s Church, Brayton on 3rd March noted and publicised on the website.

- 71. 17/18 Village Hall:** - 71.17/18.1.Purchase of Hall: The purchase is complete and was launched to the public at the Christmas Light switch on event on 8th December, which was well attended.
55.17/18.2. Running of the Hall: A management committee has been set up and work has started getting quotes for various improvements to the building. Funding to replace the curtains and blinds is being applied for and the hall is being re-decorated from 5th February by a resident who is looking for volunteers to help. Also looking into options for licensing the hall and getting broadband installed. The Plough Inn have still not removed the bottle bins from the car park.
The committee are organising a Children’s Easter event and usage is increasing with Salsa classes starting in March and Selby District AVS and the school looking to use it. Will also look into setting up the Youth Club but a local volunteer is needed to help organise it.
- 72. 17/18 Planning:** - The Parish Council have submitted an objection to the EIA Scoping Report for the proposed Ferrybridge D Combined Cycle Gas Turbine Generating Station (CCGT) Power Station. A consultation has been received for a non-material change to the Ferrybridge Multi-fuel 2 Development Consent Order. **Action:** Comments are to be submitted by 16th February.
A consultation on a gas fired power station as Drax is expected to be received soon.
- 73. 17/18 Potential Housing Development at Beech Grove Garage Area:** - No further update.
- 74. 17/18 Village Defibrillator:** - The training with Brotherton Parish Council has yet be arranged. The annual maintenance fee has been paid from the donations received.
- 75. 17/18 Website:** - The Village hall trust have asked if a booking facility for the village hall can be added, which they can have access to edit and this is being discussed with the website provider.
- 76. 17/18 Committee updates:** - 76.17/18.1 Burial Committee: Reported that all is running smoothly and the next meeting is on 20th March. **Resolved:** Cllr Foster will take over as the second representative on the committee.
76.17/18.2. Brotherton Quarry Community Liaison Committee: Complaints received about dust and mud on the road. The next meeting is on 22nd February.
76.17/18.3 Community Engagement Forum: The meeting of the Partnership Board on 26th January included an update on projects that have received funding. They are looking for new big projects to fund and Burton Salmon Village Hall is the focus of a new beginnings project.
76.17/18.4. Monk Fryston Education Foundation: The Chairman, Reverend Hetherington, has now left and a wall mural was purchased as a legacy gift. They are looking to be more proactive to show what money is available and help schools with projects.
- 77. 17/18 2017/18 Finances:-** The Council approved expenditure items totaling £615.62 and the balance in bank after all agreed expenditure is £8,775.79

78. 17/18 2018/19 Budget setting and precept agreement: - A 3% increase in the band D charge was agreed and the precept requirement was submitted to SDC. The Council approved the budget based on the agreed precept.
